Refund Policy:

- Full refunds will be made in the event of class cancellation or if student withdraws 4 business days prior to start of class.
- 75% of the tuition fee will be refunded if a student withdraws within 3 business days of the scheduled start of class.
- No refunds will be made after the start of class.
- A credit is optional in lieu of a refund. Credits will be valid for one (1) year from the date of issue. (same terms as above)

Enrollment:

Adults, 18 years of age and older, are eligible for enrollment. Depending upon certain circumstances, persons younger than 18 may be admitted. Youth, 15 years and older, are eligible for enrollment in the Driver Theory course. All courses offered if a minimum of 6 individuals enroll.

Fees:

Cash, money order, check or credit cards (MasterCard, Discover and Visa) will be accepted. A \$30.00 fee will be assessed for all returned checks. *Cost includes lab fees and materials unless noted otherwise.*

Cancelled Courses:

CMAVTS reserves the right to cancel courses, change staff and fees without prior notice for any program or course due to insufficient enrollment. If CMAVTS cancels a course, then the student is entitled to a FULL refund.
